Any securities or other property of or deposited in the name of the firm may be withdrawn and any monies may be borrowed from you in the name or on behalf of the firm, and may be secured in any manner upon any securities, monies or property of or deposited in the name of the firm by both/all/any of us or by

..... and we will be jointly and severally responsible for the repayment of such monies with interest, costs, charges and expenses.

4. In the absence of any directions to the contrary, all accounts subsequently opened shall be operated and dealt with upon the terms set out above insofar as the name may be applicable.

Upon any partner ceasing to be a member of the firm by death or otherwise, you may in the absence of written notice to the contrary from us or any of us or the legal personal representatives or trustees of any of us treat the surviving or continuing partners of partner or other partners or partner for the time being as having full power to carry on the business of the form and to deal with its assets as freely as if there had been no change in the firm.

6. This authority shall remain in force until revoked notwithstanding any change in the constitution or name of the firm and shall apply notwithstanding any change in the membership of the firm by death, bankruptcy, retirement or otherwise or the admission of any new partner or partners.

7. Closure of the Partnership's current account/current account and savings account/savings account* or any other account or accounts shall be effected only through instructions of all the current partners of the firm as of the date of instructions.
