You are hereby irrevocably and unconditionally authorised to act on any faxed instruction which you in your sole discretion believe emanate from us or otherwise appear to comply with the terms of the mandate for the above account(s) (instead of the authorisation set up for the HSBCnet E-C channel) and you shall not be liable for acting in good faith on faxed instructions which emanate from unauthorised individuals or in any circumstances whatsoever.
3. In particular you shall not be under any duty to verify the identity of the person or persons giving any faxed instruction purportedly made on our behalf or the authenticity of any signature on any faxed instruction.
4. Any transaction made (including without limitation any transfer of funds from our account(s) referred to above) pursuant to any faxed instruction shall be binding upon us whether made with or without our authority, knowledge or consent.
5. We undertake to keep you and other members of the HSBC Group indemnified at all times against, and to save you and other members of the HSBC Group harmless from all actions, proceedings, claims, loss, damage, costs and expenses which may be brought against, suffered or incurred by you and other members of the HSBC Group and which shall have arisen either directly or indirectly out of or in connection with your accepting faxed instructions from us and acting thereon, whether or not the same are confirmed in writing by us.

You agree that a fax instruction referred to in this Schedule shall be deemed to be a Customer Instruction for the purpose of the provisions in the Agreement (to the extent that such provisions can apply to the instruction received by facsimile by the Bank) unless there is a provision in this Schedule which is inconsistent with a provision in the Agreement, in which case the provision in this Schedule shall prevail to the extent of the inconsistency. Nothing herein shall affect our duties and obligations under the Agreement which shall continue in full force and effect.

Accordingly, you should not authorise our Bank to accept instructions by facsimile unless you are prepared to undertake such risks and have satisfied yourself in all respects with regard to such authorisation.**
